

## CONDITIONS FOR PERMISSION TO REPRODUCE WORKS OF ART

### CONDITIONS UNDER WHICH PERMISSION IS GRANTED TO REPRODUCE WORKS OF ART IN THE COLLECTION OF THE DENVER ART MUSEUM

1. Permission is granted for only one-time, non-exclusive usage in one publication, for one edition, and agreed upon languages. Additional language editions and subsequent new editions will be considered upon application.
2. Any publication of this work must bear a copyright notice as prescribed by the Copyright Law of the United States.
3. Reproduction from printed or photographic materials not supplied by The Denver Art Museum is strictly prohibited.
4. Reproduction of transparencies smaller than 4x5 inches is not permitted without special permission.
5. Proofs of color separations must be submitted to the museum for approval.
6. The reproduction must be halftone black-and-white or four color and may not be reproduced on colored stock. Nothing may be superimposed on the reproduction (i.e. type or color or another image).
7. The object must be reproduced in its entirety and may not be bled off the page or cropped unless the museum approves the detail in advance and the caption indicates a detail is shown.
8. The credit line, exactly as given on the invoice, must be shown in immediate proximity to the reproduction or in the section of the publication devoted to acknowledgments.
9. In the use of television or films, full credit must be included in the program credits, and when applicable, in the accompanying manual.
10. The applicant must provide the Registrar's Office with a complimentary copy of the publication, CD-Rom or videotape in which the reproduction(s) appear(s).
11. The museum assumes no responsibility for claims against the applicant or the museum by third parties. The Museum may grant the permission requested only to the extent of its ownership of the rights relating to the request. Certain works of art as well as the photographs of those works of art may be protected by copyright, trademark, or related interests not owned by the Museum. The responsibility for ascertaining whether any such rights exist, and for obtaining all other necessary permissions, remains with the applicant.
12. The Denver Art Museum (DAM) makes no warranties or representations and assumes no responsibility whatsoever for any claims against the applicant or the Museum by the artists, their agents, estates, or by any parties in connection with the reproduction of works of art in the collection of the DAM. The applicant agrees to indemnify DAM and hold is harmless against any and all such claims, including copyright infringement claims, royalty or fee demands and/or actions, including the costs thereof arising as a result of the applicant's reproduction of the works in the collection of DAM. Copyright ownership and/or reproduction rights may be retained by the artist for works of art created after January 1, 1978. Any and all royalty payments or other requirements specified by the copyright owner of such a work must be paid or honored by the publisher or agent requesting reproduction permission.
13. The applicant agrees to have the legal right and power to the terms in this application. This is the entire agreement between the parties hereto, and any dispute shall be arbitrated in the City of Denver, State of Colorado.

1. **The Denver Art Museum Application for Permission to Publish will be forwarded in response to your written request. Complete the application as thoroughly as possible.**
2. **Please include:**
  - a. List of objects and if available, the accession numbers.
  - b. Photocopy or electronic low-resolution file of image.
  - c. If you are uncertain about specific objects from the collection and your request requires research work, it will take longer to supply you with a photographic image. This type of research is performed by contract help as available.
3. **Briefly explain the type of publication, interior or cover use, print run, reproduction size (i.e. ¼, ½, full page), one or multi-languages, North American or worldwide distribution, author, publisher and expected date of publication.**
4. **Specify photographic material needed:**
  - a. 8x10 inch black and white glossy print with border (for study or publication)
  - b. 35mm slides (for lecture/study)
  - c. electronic file:
    - i. For publication purposes, we provide high quality scans, TIFF, 300 dpi, 8x10" 22-50 mgb or more if requested, onto a CD with a colormatch digital print. Imacon scanner and software. We could convert a color image to black & white if needed.
    - ii. For Powerpoint presentations or layout purposes, we provide scanned images at jpeg, 72 dpi, 800x600 pixels
5. **Your request will be reviewed by the curatorial departments.**
6. **If approved, a letter will be sent to you including our invoice with terms and proper credit line.**
7. **Average turn around time for delivery of product is three weeks AFTER payment has been received. Average requests are fulfilled between 4-6 weeks depending on the nature of the request.**
8. **A rush fee of \$200 will be applied for orders due within one week.**
